Dear Residents

The Board of Directors met again this morning to discuss the recent developments relating to COVID 19 and the revised regulations released by Government. Please click on the link below to view the Government Gazette released recently.

The Board requested all major service providers (Life Landscapes, Mark Wiltshire Golf, Omega Risk Solution and Prentec) to submit their contingency plans regarding the spread of the virus. It was reviewed during the meeting, and the Board feels comfortable that they are taking all reasonable precautions to protect their staff and our residents. The PHOA will monitor, as far as possible, that the service providers adhere to their own guidelines. We have also developed precautionary measures to try and protect our staff and residents. A mutual agreement will be signed by all staff members pledging their commitment to adhere to the PHOA guidelines.

Parents should be aware that it is an impossible task to sanitize the jungle gyms, all parents are requested to take the necessary precautions when their children play on the jungle gyms etc. i.e. wash and sanitize their hands before and after play, remind children to not touch their faces.

We have obtained quotations for the screening devices and procurement will commence ASAP.

Golf Operations

The following precautionary measures have been implemented:

- All our rental Club Carts will be sanitized before and after use, with a one user per cart policy
- one tee start all off-1st tee to spread the field
- Alcohol will only be served between 09h00 -18h00 Monday -Saturday, Sundays between 09h00 -13h00
- Food and beverage are investigating creative ways of supplying our residents with meals at / from the restaurants, more information to follow.
